While most media attention is focused this week on the Senate debate on the economic stimulus package, the Obama administration is preparing to roll out a new plan to bail out the banks, involving a trillion dollars or more in public assets

Well aware of popular opposition to the Wall Street bailout, the White House and the media are engaged in a calculated campaign to soften up public opinion and pave the way for a taxpayer handout to the financial elite even bigger than the \$700 billion already doled out in the Troubled Asset Relief Program (TARP), which was rushed through Congress last autumn with the support of then-presidential candidate Obama. The total cost of government cash infusions, loans and guarantees to the major banks and financial firms, already estimated at \$8 trillion, will soar even higher, by far eclipsing the money allocated in the so-called stimulus and recovery program.

Okay not so bad so far...

In other words, the ruling elite will emerge from this process richer than ever. The American people—who have no responsibility for the economic disaster—will be left to pay the bill through drastic cuts in social benefits, including bedrock programs like Social Security and Medicare, and a continuous erosion of their jobs and living standards.

The proposed bill, which has received little mainstream media attention, appears designed to create the type of detention center that those concerned about use of the military in domestic affairs fear could be used as concentration camps for political dissidents, such as occurred in Nazi Germany.

Speaking of the Government gulag here's one woman lucky enough to escape what the gang bankers have in mind for "The Late Great USA".

**Moving back to Uncle Sam's plantation** (worldnetdaily.com 2/7/09)

As the American News Project video posted below reveals, the Federal Reserve has doled out around \$2 trillion to unknown suspects behind our backs, described as a "staggering, enormous, unprecedented sum of money." Of course, we have a pretty good idea who the recipients are, never mind all the secrecy — the international bankers, the same people who took more than \$8.5 trillion under threat last year from your children and grand-children.

If not for freshman Congressman Alan Grayson of Florida, you might not be any wiser about this latest scam. In the video, Grayson grills Fed vice-boss Donald Kohn over the "lending" of an addition \$2 trillion to unspecified "institutions," a highly unusual situation because our congress critters rarely — with the notable exception of Rep. President Obama has expressed his belief the U.S. Constitution should be interpreted through the lens of current events, and now he's apparently preparing to install as a senior official at the U.S. Justice Department a lawyer who goes one step further, advocating for constitutional protections for abortionists, pornographers and protesters.

"Ogden is an abortion-on-demand absolutist. He opposes common sense restrictions on abortion, including policies that have significant support from the American people, such as parental notification by minors," the organizations said in a report today.

Also, "Ogden is an absolutist on pornography and obscenity. He opposes common sense restrictions on the ability of pornography peddlers to sell their products. He believes pornography users have a constitutional right to view pornography at a public library."

"David Ogden is a hired gun from Playboy and ACLU," said Brian Burch, president of the pro-family group. "He can't run from his long record of opposing common sense laws protecting families, women, and children. The United States Senate has a responsibility to the American people to insure that Mr. Ogden's full record is fully reviewed before any vote on his nomination."

The group's extensive research on Ogden cites his work on behalf of homosexuality in Lawrence vs. Texas, for Playboy and Penthouse on issues involving pornography and his representation of a company that distributes videos titled "Bubblegum cuties," "Sweet young things," "Young girls" and "Fresh and young."

"He has opposed filters on library computers protecting children from Internet smut, and successfully defended the right of pornographers to produce material with underage children," Burch said.

**Pro-Abortion Marie Stopes Eager for American Funds to Promote Abortion in Kenya** (infowars.com 2/3/09)

The leader of the Kenyan division of Marie Stopes, one of the worlds largest abortion providers, has told an AP reporter that he is eager to receive American funds now that President Obama has rescinded the Mexico City Policy.

"Family planning was not given the prominence it needs" when the policy was still in effect, said director Dr. Walter Odhiambo in an AP report.

The Mexico City Policy is a Reagan-era directive that prohibits pro-abortion overseas organizations from receiving American taxpayer dollars. Obama repealed the policy three days after his inauguration, making hundreds of millions in foreign aid money available to such groups.

Pro-life voices in Kenya have denounced the encroachment of the foreign-funded abortion culture as a threat to the deeply pro-life Kenyan people, who are now faced with a bill that would legalize abortion. Kenyan secular and religious leaders have condemned the bill in no uncertain terms, saying that innocent unborn child must not be destroyed for convenience.

“We in Kenya know him (Obama) as a person who is anti-family,” he said, following Obama’s November election victory. “A person who would support abortion. In America they can do all right killing their babies. But they must not associate us with the people who would want our babies to be killed.”

Dr. Karanja said that 90 percent of those in Kenya polled over the last twenty years consider abortion to be an “abomination.”

Dr. Karanja criticized the concept that poorer countries such as Kenya benefitted from organizations pushing population control.

“The only resource we have that is truly ours,” he said, “is our people. Don’t attack them and we’ll be alright. And this administration of Obama, is going to be a nightmare for our people.”

So who was Marie Stopes? Well just in case you still think this all just “conspiracy theory” here’s a useful article:

**Marie Stopes: Eugenics by Abortion** ([abortionabout.com](http://abortionabout.com), 2/3/09)

Marie Carmichael Stopes (October 15, 1880 – October 2, 1958) was a Scottish sexologist, eugenicist, and campaigner for women’s rights. A flamboyant and often arrogant figure who considered herself the best authority on the topics of love, marriage, sex, and birth control, Stopes was criticized during her lifetime for advancing ideas that were in sometimes outdated and not proper for all people.

Marie became interested in the subject of birth control after meeting Margaret Sanger, a birth-control campaigner from America. Sanger had converted to socialism and begun publishing her own newspaper where she argued in favor of birth control and abortion. The main theme of her articles was that “no woman can call herself free who doesn’t own and control her own body.” In 1915, when charged with publishing an “obscene and lewd article,” Margaret Sanger fled to Britain and while in London, met Marie Stopes.

Stopes became a prominent campaigner for eugenics, a brutal movement that inflicted massive human rights violations on millions of people. The movement, led by race scientists and financed by private philanthropies such as the Carnegie Institute and the Rockefeller Foundation, was implemented by governments in North America, Europe (particularly Nazi Germany), and Australia, to name a few. Eugenics targeted the poor, mentally ill, blind, ‘promiscuous women’, homosexuals, and entire “racial” groups, such as Blacks, the Roma, and Jews,

considering these people as “degenerate” or “unfit.” Eugenics advocated the segregation or institutionalization of such individuals and groups, their sterilization, their “euthanasia,” and in the worst case of Nazi Germany, their mass extermination. The practices engaged in by eugenicists involved violations of privacy, attacks on reputation, violations of the right to life, the right to found a family, and violations of the most fundamental human rights.

Here’s another concerning the Chinese and RU-486 from the “conspiracy theorists” over at the Washington Post:

**Chinese to Make RU-486 for U.S.: FDA Has Sought to Shield Source of Abortion Drug** (washingtonpost.com 10/12/2000)

SHANGHAI, Oct. 11 — The Hua Lian Pharmaceutical factory emerges from fields of sorghum and green onions an hour's drive south of downtown Shanghai. At quitting time, workers board company buses that take them back to the city. Others leave on bicycles, pedaling toward nearby villages along narrow lanes dotted with oxen.

Despite the tranquil appearance, the Hua Lian plant is a secret factory of sorts. Its name and location are shielded not by Chinese authorities, but by the U.S. Food and Drug Administration, which two weeks ago approved the sale of a product that workers here are preparing to churn out for the American market--the abortion drug RU-486.

RU-486 has been a key ingredient in China's population control strategy for years. Of the estimated 10 million abortions performed annually in China, about half are carried out with RU-486, said Gao Ersheng, director of the Shanghai Institute of Planned Parenthood Research.
