WASHINGTON – Authors of a new book who were sympathetic to Hugo Chavez's 1998 presidential bid to "eradicate poverty" in Venezuela now say he is a greater threat to America's national security than Osama bin Laden and has the means and motive to bring the U.S. to its knees.

In "[The Threat Closer to Home: Hugo Chavez and the War Against America.](#)" Douglas E. Schoen and Michael Rowan say the U.S. is oblivious to Chavez's intentions to use oil as an asymmetric weapon of war, as well as terrorism, in attacks that could rival 9/11 in their impact on the economy and infrastructure of the nation.

Chavez has used Venezuela's vast oil resources to support the government of Iran – and specifically its nuclear ambitions, they say. He also has permitted the largest jihadist terror organization in the world, Hezbollah, to maintain permanent bases in Latin America and recruit Venezuelans.

News bailouts threaten freedom of press
'You can't expect a watchdog to bite the hand that feeds it'
(worldnetdaily.com 2/11/09)

Floundering media and news conglomerates have expressed interest in accepting government bailout money, leading some to object, arguing that strings attached to federal funds will subvert our nation's freedom of the press.

Brent Bozell, president of the media watchdog organization Media Research Center, contends that if a news company – even one – accepts taxpayer money, it can no longer be trusted to hold government accountable to the people.

"How in the world can [a] paper propose to be a watchdog for the public when it's had conversations about being bankrolled by the government?" Bozell asked in *The Philadelphia Bulletin*.

"When a media outlet proposes a bailout, it proposes to put itself under the authority of the entity bailing it out," Bozell said. "Therefore, if it's a government, the media entity proposes to become an arm of the government."

3. WATCH OUT FOR THIS GUY

Banksta owned Snewsweek ummm Newsweek came out with this beauty this past week. There it was, just before the commercial: the S word, a favorite among conservatives since John McCain began using it during the presidential campaign. (Remember Joe the Plumber? Sadly, so do we.) But it seems strangely beside the point. The U.S. government has already—under a conservative Republican administration—effectively nationalized the banking and mortgage industries. That seems a stronger sign of socialism than \$50 million for art. Whether we want to admit it or not—and many, especially Congressman Pence and Hannity, do not—the America of 2009 is moving toward a modern European state.

We remain a center-right nation in many ways—particularly culturally, and our instinct, once the crisis passes, will be to try to revert to a more free-market style of capitalism—but it was, again, under a conservative GOP administration that we enacted the largest expansion of the welfare state in 30 years: prescription drugs for the elderly. People on the right and the left want government to invest in alternative energies in order to break our addiction to foreign oil. And it is unlikely that even the reddest of states will decline federal money for infrastructural improvements.

And if it sounds like George Orwell’s 1984 – it is. (Antony C. Sutton, “America’s Secret Establishment: An Introduction to the Order of Skull and Bones”, (Trine Day Publishing, 1983, 2002) p. 34.

Ruin Your Health With the Obama Stimulus Plan: Betsy McCaughey

Feb. 9 (Bloomberg) -- Republican Senators are questioning whether President Barack Obama's stimulus bill contains the right mix of tax breaks and cash infusions to jump-start the economy.

Tragically, no one from either party is objecting to the health provisions slipped in without discussion. These provisions reflect the handiwork of Tom Daschle, until recently the nominee to head the Health and Human Services Department. Senators should read these provisions and vote against them because they are dangerous to your health. (Page numbers refer to H.R. 1 EH, pdf version). The bill's health rules will affect "every individual in the United States" (445, 454, 479).

Your medical treatments will be tracked electronically by a federal system.

But the bill goes further. One new bureaucracy, the National Coordinator of Health Information Technology, will monitor treatments to make sure your doctor is doing what the federal government deems appropriate and cost effective. The goal is to reduce costs and "guide" your doctor's decisions (442, 446).

Hospitals and doctors that are not "meaningful users" of the new system will face penalties. "Meaningful user" isn't defined in the bill. That will be left to the HHS secretary, who will be empowered to impose "more stringent measures of meaningful use over time" (511, 518, 540-541)

Elderly Hardest Hit

Daschle says health-care reform "will not be pain free." Seniors should be more accepting of the conditions that come with age instead of treating them. That means the elderly will bear the brunt.

Medicare now pays for treatments deemed safe and effective. The stimulus bill would change that and apply a cost- effectiveness standard set by the Federal Council (464).

On Friday, President Obama called it "inexcusable and irresponsible" for senators to delay passing the stimulus bill. In truth, this bill needs more scrutiny.

This stimulus is dangerous to your health and the economy.

Of course this "bailout" had to be passed so quickly it couldn't even make the five day review period for "more transparency" promised by candidate Obama. Maybe there's more than "just" the Orwellian concept of a "Federal Council" to determine the "meaningful users" of the "free" Government health care system:

Mystery Fireball Streaks Across Texas Sky (foxnews.com, 2/16/09)

"We don't know what it was," said Federal Aviation Administration spokesman Roland Herwig.

The Williamson County Sheriff's Office used a helicopter to search after callers said they thought they saw a plane crashing, a spokesman said.

The U.S. Strategic Command said there was no connection to the sightings over Texas and Tuesday's collision of satellites from the U.S. and Russia.

"There is no correlation between the debris from that collision and those reports of re-entry," said Maj. Regina Winchester, with STRATCOM.
